Dear Vacation Cottage Owner/ RV Seasonal Guest,

On April 7th we advised that due to the [Stay-at-Home Order](#) and [Ontario Regulation 82/20](#) that the resort would be closed for the duration of this order.

Subsequently, Sun RV Resorts sought further clarification from our legal counsel and have been advised that in accordance with Regulation 82/20, we are able to open the resort as of May 1, 2021 for Vacation Cottage Owners/ RV Seasonal Guests permitted by the terms of a full season contract and provided that the Vacation Cottage Owner/ RV Seasonal Guest abides by the terms of the Stay-at-Home Order while at the resort. Access to the resort will only be provided to those that have submitted a signed copy of their 2021 License of Occupation (LOC) and only for those individuals identified on the LOC. No visitors are permitted during the Stay-at-Home Order.

We will require all Vacation Cottage Owners/ RV Seasonal Guests attending the resort to review the Stay-at-Home Order and be familiar with its terms. The Stay-at-Home Order provides, in part, as follows:

Requirement to remain in residence

1. (1) Every individual shall remain at the residence at which they are currently residing at all times unless leaving their residence is necessary for one or more of the following purposes:

Multiple residences and moving

19. Travelling to another residence of the individual if,
 - i. the individual intends to be at the residence for less than 24 hours and is attending for one of the purposes set out in this Order, or
 - ii. the individual intends to reside at the residence for at least 14 days.”
20. Travelling between the homes of parents, guardians or caregivers, if the individual is under their care.
21. Making arrangements to purchase or sell a residence or to begin or end a residential lease.
22. Moving residences.

Once at the resort, we ask that you remain at your site unless otherwise permitted in accordance with the Stay-at-Home Order and that you adhere to all regulations therein. A copy of the Stay-at-Home Order is available through the above link and will be posted at various locations throughout the resort.

As a reminder, all facilities within the resort will remain closed while the Stay-at-Home Order is in effect.

All reservations including cottage rentals, campsites and private rentals are not permitted under the Stay-at-Home Order. We will provide further communication on this topic as it becomes available.

The changes to the public health legislation have not been a simple matter to navigate and we apologize for any confusion and/or inconvenience this may have caused. While we had hoped to open earlier please appreciate that this matter is outside of our control. We understand this is disappointing news and look forward to opening all of our amenities as soon as we are allowed to do so.
